

## BCV Reopening Guidelines – Revised 06/18/2020

1. Physical distancing and the wearing of face coverings over the nose and mouth is required in Stonehouse. The Long Reach Community Association is limiting lobby occupancy to essential personnel only.
2. Please note the following changes to dropping off and picking up students:
  - a.) All students who are dancing upstairs in the Plaza Room (studios A and B) are to be dropped off with their teacher at the side door of the Plaza Room and picked by their parent at the front door of the lobby.
  - b.) All students who are dancing downstairs in the Montgomery Room (Studio C) are to be dropped off with their teacher at the downstairs entrance at the end of the hall and picked up by their parent at the downstairs door leading out of the Tamar Room (studio D).
  - c.) Parents and dancers are to line up outside the building and wait for the teacher to come get them before class. Please be prompt so that you arrive when the teacher is there to greet you and bring your child into class. Parents of children ages 2 – 7 will be required to sign their children out when picking them up. Please be prompt when picking up your child.
3. For children ages 2 through 7, a “class parent” will be designated for each class meeting to assist students during class if necessary. After parents enroll their child, they will have the opportunity to volunteer as a class parent. The designated “class parent” only may wait in the lobby during class.
4. Face masks are to be worn by staff and dancers age 8 and up, as long as they can be worn safely and consistently. Face masks for children 2-7 are recommended but not required. Younger children may touch their face more while wearing a face mask, which can spread more germs than not wearing one.
5. Frequent handwashing will be required before, after and during class as necessary. Hand sanitizer will be available in the dance studio. Signage will be posted as a reminder of safe hand washing procedures. Our ABC’s and/or Happy Birthday will be sung frequently!
6. All highly touched surfaces and equipment will be cleaned and disinfected daily.
7. Classes will be kept to a maximum number of 10, including the instructor.
8. A marked system will be in place to visually remind students to maintain a safe distance of 6’ apart.
9. Any students or staff showing any symptoms of illness are to stay home. Please notify your instructor if your child will be absent from class. Staff temperature checks will be taken as long CDC recommendations are in place.
10. Parents must update their contact and medical information in Jack Rabbit so that we can contact you quickly and respond appropriately in the event of an emergency.
11. To avoid overcrowding the rest rooms, please get dressed for class at home.
12. The water fountain will not be available. Please bring and label you own water bottle.
13. Whenever possible, pay your tuition on line. If you prefer to pay by check, put your check in an envelope and hand it directly to your instructor with all pertinent information on the outside of the envelope. Tuition is payable to The Long Reach Community Association.
14. All students over the age of 18 and guardians of students under the age of 18, an employees and staff of Ballet with Cindee, LLC are required to sign our Release of liability regarding covid-19.
